CONDITIONS for MONTHLY EXHIBITIONS

NAME – Oatley 101 SOCIETY of ARTISTS Inc Gallery Weekend Exhibition

VENUE – 1st Oatley West Scout Hall - 101 Woronora Parade, Oatley West 2223

ENTRIES: A maximum number of four (4) paintings may be entered by exhibiting members. Entries must be the unaided, original work of the artist.

Please note- an “Exhibiting Member” is a member of Oatley 101 who has been accepted for hanging in the Art of Sydney Awards.

Each entry must be clearly labelled on the back with the following ‘vital’ information -

- a) Name of the artist
- b) Title of work
- c) Price of painting

Paintings must be properly framed with hanging cord - hooks screw eyes and other metal projections on the back of the painting are not acceptable. However, padded D rings are acceptable.

DEEP EDGE CANVASES – Paintings may also be entered on unframed, deep edge, 38mm (1½”) artist quality stretched canvas, professionally stapled at the back. Sides of the canvas must be painted. **Narrow edge canvases, and canvases stapled at the side will not be accepted for the exhibition. Only paintings with professionally stapled or D-ring fittings with soft hanging cords will accepted.**

ENTRY FORM - Please send to Freda Surgenor, 41 Frobisher Avenue Caringbah 2229 to reach her by the Tuesday before the exhibition.

Please note: Please do not leave entry form at Hall, it must be posted to Treasurer

ENTRY FEES: \$3.00 non- refundable entry fee is applicable for each painting. All works must be for sale. A 25% commission will be charged on all sales.

COPYRIGHT - The artist is decreed to have accepted sole responsibility for ensuring that works exhibited do not infringe any relevant Copyright Laws.

GST – As Oatley 101 Society of Artists is required to hold an Australian Business Number (ABN) – it is important that information regarding your position and the New Tax system (GST) be filled in appropriately on the Entry. ‘A Statement by a Supplier’ Form is required by us from those people who are not registered for the GST and do not hold an ABN.

***However, if we already hold a Statement form from you, please do not send another one.**

INSURANCE - The greatest care will be taken with all works, however, Oatley 101 Society of Artists Inc., the Australian Scout Association NSW Branch as owners of the hall, and Hurstville City Council as owners of the land, will not accept responsibility for loss or damage to any paintings. Artists are required to organise their own Insurance.

DELIVERY OF PAINTINGS - Paintings must be delivered to the venue on -the FRIDAY between 5pm and 6pm.

Please do not leave paintings at Hall before delivery day.

COLLECTION OF PAINTINGS - Paintings must be collected after the exhibition on - SUNDAY, between 5pm and 6pm during Daylight Saving and between 4pm and 5pm during Eastern Standard time.
